- New Build topsides oil and gas production equipment which can include Power Generation Packages, Gas Compression, Water Injection, various types of pressure vessels, electrical components, and various other mechanical and electrical packages.
- Concrete Gravity Base Structures materials and mechanical packages.
- Off-loading Systems.

Activities to be undertaken on behalf of client for the above at a minimum would be:

- Ensure that required delivery dates are respected and met.
- Carry out Audits as requested.
- Attendance at pre-production meetings.
- Monitoring of engineering.
- Input into sub-supplier surveillance programs.
- Monitoring of manufacture process through ITP's.
- Attendance at Factory Acceptance Testing.
- Final equipment acceptance.
- Documentation approval and order close out.

All vendors responding must have resources necessary to effectively execute the above scopes of work and, in addition, well documented experience in executing Subsea, Topsides, and GBS, surveillance programs on both a local and global basis.
