## **Scope of Work Overview:**

Drilling and Completions Overview:

- The Hebron Development comprises five pools.
- The drilling package will contain 52 slots.
- Platform wellbores will have three-dimensional trajectories with long horizontal sections requiring extended reach drilling (ERD) profiles.
- Project will consist of:
  - Oil Producer wellbores with open hole screen completions and gas lift completion designs with downhole chemical injection
  - Water injection wellbores with either cased hole or open hole screen completions
  - Gas injection wellbores with either cased or open hole screen completions

The scope of work/supply includes, but is not limited to:

Provision of a cuttings re-injection service and a drilling drains service for the purposes of executing drilling operations for offshore wellbores drilled from the Hebron Platform, in the Eastern Canadian Grand Banks environment offshore Newfoundland and Labrador. The Work shall include all personnel necessary for the operation of the cuttings re-injection system and the drilling drains system, as prescribed by Company. The Work shall also include all necessary onshore support infrastructure and personnel necessary to support offshore operations including engineering services. This set of specifications is limited to Hebron Platform operations.

Cuttings re-injection operations will be conducted from a company owned cuttings re-injection package incorporated into the Hebron facility. Supply of the cuttings re-injection system for the Hebron Platform is not considered as part of the scope of supply herein.

The successful vendor responsibilities shall include, but not be limited to, the following:

- 1. Provision of experienced, trained, and competent personnel to operate, manage, and maintain the cuttings re-injection system and drilling drains system on the Hebron Platform,
- 2. Provision of suitable engineering and project support for carrying out all re-injection services including cuttings re-injection monitoring, verification of cuttings re-injection performance, and analysis of injection data,
- 3. Operation and maintenance of cuttings re-injection equipment on the Hebron Platform.

Additionally, the selected contractor will be required to meet all technical and Safety, Health, Environmental, and Security (SHE&S) specifications and safe work practices of ExxonMobil and its affiliates as appropriate.

Vendor submissions in response to this Expression of Interest **must** include the afore-mentioned reference number, as well as the following information:

- 1. Information demonstrating qualification for the Scope of Work detailed above.
- 2. Describe your experience operating under and familiarity with, the benefits provisions of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Acts and your experience with any similar regimes in other parts of Canada or internationally. At the RFP/ITT stage, bidders will be required to indicate how they comply with the above.
- 3. Please acknowledge that responsible management personnel have read, understand and will support requirements to comply with the following where applicable:
  - i) Section 45 of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act
  - ii) The Hebron Benefits Agreement and Hebron Benefits Plan work requirements

The data submitted will be used to do a preliminary evaluation of your company's ability to perform these services. Additional evaluation in the form of a prequalification should be anticipated in advance of ExxonMobil finalizing a bidders list.

This Expression of Interest (including pre-qualification) is not a pre-qualification of contractors for other ExxonMobil work, but is limited to the scope aforementioned. In addition, participation in this Expression of Interest (including pre-qualification), including any statements whether oral or written between ExxonMobil and your company, shall not create or be deemed to create any binding legal relationship or contract, or be construed to do so between ExxonMobil and your company. All costs associated with the preparation of your response to this expression of interest shall be at your expense.

This Expression of Interest (including pre-qualification) may or may not result in the issuance of an RFP/ITT and may or may not result in the award of a contract.
