

EXPRESSION OF INTEREST (including Pre-Qualification Requirements)

Supply of IT and ICSE Support Services for Hibernia and Hebron

Overview:

- ExxonMobil Canada Properties, by its managing partner ExxonMobil Canada Ltd. (EMCP) and Hibernia Management and Development Company Ltd. (HMDC) are in the process of pre-qualifying companies who can supply IT and ICSE Support Services for their onshore and offshore Newfoundland and Labrador requirements.
- Supplier shall provide all management, personnel, processes, equipment, applicable certifications and facilities as may be required to ensure all equipment covered by this pending Agreement shall be supplied to meet all statutory requirements, codes of practice and applicable specifications.
- The intention is to have this scope of work cover the requirements of the Hibernia Project* and the Hebron Project. For clarity, the scope of work includes not only the foregoing, but may include at EMCP and/or HMDC's discretion, future work related to minor changes to the scope of work described herein, in which EMCP and/or HMDC may engage onshore or offshore Newfoundland and Labrador, for oil and gas facilities as well as exploration or subsea related activities.
- While not planned, it should be noted that the resulting RFP and Agreement may require inclusion of and/or extension to other operators in the area, project co-venturers, suppliers and/or affiliated companies.
- For work related to the Hibernia Project*, HMDC supports providing opportunities to Canadian, and, in particular, Newfoundland and Labrador companies and individuals, on a commercially competitive basis. Suppliers expressing interest in providing services or materials, if they are selected to bid, will be required to complete a Canada-Newfoundland and Labrador Benefits Questionnaire at the bid stage.
- For work related to the Hebron Project, EMCP supports providing opportunities to Canadian, and, in particular, Newfoundland and Labrador companies and individuals, on a commercially competitive basis. Suppliers expressing interest in providing services or materials, if they are selected to bid, will be required to complete a Canada-Newfoundland and Labrador Benefits Questionnaire at the bid stage.
- Hibernia Management and Development Company Ltd. (HMDC) and ExxonMobil Canada Properties, by its managing partner ExxonMobil Canada Ltd. (EMCP), encourages the participation of members of designated groups (women; Indigenous Peoples; persons with disabilities; and members of visible minorities) and corporations or cooperatives owned by them, in the supply of goods and services.

Scope of Work Overview:

The scope of work/supply includes, but is not limited to:

- Provision of IT and ICSE (Industrial Control Systems Environment) professional services to support onshore and offshore needs. This includes support for all Operations and Drilling systems (onshore and offshore) and providing Cyber Security monitoring and surveillance per ExxonMobil guidelines, including system maintenance, upgrades, and general technical support requirements.
- Systems to be supported include the following (note that this is not an exhaustive list):
 - Drilling: DCD/DDAS, bulk material transfer system, completions system, BOP control system, ASDS
 - Requires knowledge in Siemens WINCC, Wonderware and Allen-Bradley RS Logic applications
 - Productions/Maintenance: ECS Triconex, ProcessVue, Siemens Global Access, power management system, crude oil level measurement system, ice radar system, operator consoles, wireless network

- Requires knowledge in the ABB 800xA environment, Wonderware, Solarwinds, all versions of MS Windows Server and Workstation, and Modicon applications
- Platform Business Systems: Desktop/server/printer and network hardware, backups of Platform information, misc. applications support
 - Requires knowledge in Veeam, VMWare, SQL databases, and QNAP network storage
- Other potential systems to be supported:
 - Onshore Control Room networking, applications, etc., including all applicable ICSE requirements
 - Cisco Telepresence and other remote video conferencing systems
 - Industrial telecommunications and associated systems (e.g. radio, GPS, radar, microwave, etc.)
 - Requires knowledge in general industrial telecommunications, emergency communication, weather monitoring, navigational aids, collision avoidance, spill detection, etc.
- Development and stewardship of a work tracking process to enable effective and timely completion of tasks and key deliverables associated with the provided service, including ongoing ICSE support items, as well as required upgrades to maintain system health and security compliance

Additionally, the selected supplier will be required to meet all technical and Safety, Security, Health, and Environmental (SSHE) specifications and safe work practices of EMCP, HMDC, and their affiliates as appropriate.

Work Location Expectations

Through the provision of these services, although it is expected that work will primarily be based onshore, it may be required to provide support on the Hibernia or Hebron facilities. Additionally, it is expected that periodic travel offshore will be required to enable knowledge transfer and familiarization, as well as to support major upgrades to platform systems.

Minimum Technical Requirements

The selected supplier will be required to meet the following technical requirements:

- 10+ years of experience within the industrial IT support industry (networking, servers, and software)
- Knowledge and expertise in industrial cyber security and system health management / threat mitigation
- Applicable experience supporting the Oil and Gas industry (or equivalent), including systems and application knowledge as noted above
- Demonstrated range of experience in all facets of IT support, hardware and software, including hands-on knowledge, covering equipment vintage 1990 to present

Submission Requirements

Supplier submissions in response to this Expression of Interest (including pre-qualification) **must** include the afore-mentioned reference number, as well as the following information:

1. Completed EMCP / HMDC SSHE pre-qualification questionnaire. (Available through BIDS – see contact information below.)
2. Completed EMCP / HMDC QA/QC pre-qualification questionnaire. (Available through BIDS-see contact information below.)
3. Information demonstrating qualification for the Scope of Work detailed above.
4. Information demonstrating vendor can meet minimum technical requirements detailed above.

5. Describe your experience operating under and familiarity with, the benefits provisions of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act and your experience with any similar regimes in other parts of Canada or internationally. At the NRFP/ITT stage, bidders will be required to indicate how they comply with the above.

6. Please acknowledge that responsible management personnel have read, understand and will support requirements to comply with the following where applicable

- i. Section 45 of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act
- ii. The Hebron Benefits Agreement and Hebron Benefits Plan
- iii. The Hibernia Benefits Plan, the HSE Benefits Agreement and HSE Benefits Plan

Submitted information is to be provided in separate PDF (or native file) submissions and not submitted as one combined file. Please be aware that Company is limited to a 10MB file size for receiving e-mail. Should the file size exceed 10MB, please contact the Contracts Manager identified below to have FileShare setup for your use.

The data submitted will be used to do a preliminary evaluation of your company's ability to perform these services. Additional evaluation in the form of a prequalification should be anticipated in advance of EMCP and HMDC finalizing a bidders' list.

The data submitted in response to the aforementioned questionnaires will be used to evaluate your company's ability (and those of your preferred sub-contractors / suppliers where applicable) to perform these services or provide these materials.

It will focus primarily on:

- Applicable experiences
- Current capability
- Personnel qualifications

We will evaluate this data and develop a final list of suppliers who will be asked to submit formal competitive bids. We reserve the right to make the final determination of which suppliers will receive the Non-Binding Request for Proposals (NRFP) or Invitation to Tender (ITT) and which suppliers will be awarded the final agreement.

This Expression of Interest (including pre-qualification) is not a pre-qualification of suppliers for other EMCP / HMDC work, but is limited to the scope aforementioned. In addition, participation in this Expression of Interest (including pre-qualification), including any statements whether oral or written between EMCP / HMDC and your company, shall not create or be deemed to create any binding legal relationship or contract, or be construed to do so between EMCP / HMDC and your company. All costs associated with the preparation of your response to this expression of interest shall be at your expense.

This Expression of Interest (including pre-qualification) may or may not result in the issuance of an RFP/ITT and may or may not result in the award of an agreement. If you respond to this Expression of Interest (including pre-qualification) and your company is selected to be on the bidders' list, your company name, your designated company representative's name and business contact information may be posted on public websites. Similarly, if you are selected for award, the same information may also be posted, indicating that the work has been awarded to your company.

* It should be assumed that the Hibernia Project includes, but is not limited to, current and planned Hibernia and Hibernia Southern Extension operations as well as future development on behalf of Hibernia (operated by Hibernia Management and Development Company Ltd.) and/or Hibernia Southern Extension participants (operated by ExxonMobil Canada Properties).
