One of the identified employees must be able to respond in person to the Emergency Response Centres at 20 Hebron Way, St. John's.

Additionally, the selected supplier will be required to meet all technical and Safety, Security, Health, and Environmental (SSHE) specifications and safe work practices of EMCP, HMDC, EMCL and its/their affiliates as appropriate.
